**ROLL OUT OF NEW VERTICAL**

It has been brought to our attention that a new vertical to deal exclusively with Financial Inclusion is being rolled out in Chandigarh Circle on a pilot basis. We have been hearing unconfirmed reports about creation/ cessation of new Regions/Modules and reallocation of networks etc. It is clear that if such a vertical is created, there would be massive structural changes in HR policies, which need to be addressed before implementation of this project.

02. As major stake holders, we expect to be taken into confidence before embarking on such projects. We, therefore, urge upon your good office to convene a meeting of the management functionaries with the principal office bearers of both the Federations, forthwith to deliberate on certain critical issues particularly on HR related.
