## GIST OF e-CIRCULARS

We are hereby presenting the gist of staff related e-circular titbits for the month of July 2024.

### **STAFF: MISCELLANEOUS PERFORMANCE LINKED INCENTIVE (PLI) BASED ON CDS GRADING FOR FINANCIAL YEAR 2023-24**

The Scheme for Performance Linked Incentive (PLI) based on CDS grading was last approved by the Central Board in its meeting held on 27th September, 2017. Accordingly, the Competent Authority has accorded approval for the payment of PLI based on CDS Grading for the financial year 2023-24 to all employees who were graded 'A' and above, in CDS as on 31st March, 2024.

### **STAFF: MISCELLANEOUS BANK'S MEDICAL REIMBURSEMENT SCHEME FOR AYURVEDIC TREATMENTS**

The circular mentions the salient features of the Bank's medical reimbursement scheme for Ayurvedic Treatments for officers & Award Staff with improved benefits.

### **POLICY ON FRAUD RISK MANAGEMENT**

The Policy on Fraud Risk Management has been reviewed as per the regulatory prescriptions and aligned with the Bank's latest instructions. The review of the Policy has been approved by the Central Board of the Bank in its meeting held on 19th June 2024. The Policy lays down the framework for prevention, detection, reporting of frauds and taking timely actions like reporting of fraud to the regulator, investigating agencies and examining staff accountability etc. by the operating units including Branches, RBOs, AOs, LHOs and also the Business Units.

### **INCREASE IN CONVEYANCE ALLOWANCE TO EMPLOYEES HAVING BENCHMARK DISABILITY IN HARD OF HEARING, SPEECH DISABILITIES, VISUALLY, INTELLECTUALLY AND ORTHOPAEDICALLY HANDICAPPED**

Government of India has approved the upward revision of the rate of conveyance allowance payable to the persons with hard-of-hearing, speech disabilities, visually, Intellectually & Orthopedically Handicapped employees in public sector banks from Rs.400/- to Rs.600/- p.m. (payable uniformly at all places), vide notification No. eF.No.4/1/10/2022-IR dated 15.03.2024. In case of workmen staff, the allowance will be in addition to the transport allowance payable to all workmen as per the clause 16 (iii) of 12th Bipartite Settlement dated 08.03.2024. In case of officers, the allowance is in addition to reimbursement of conveyance charges.

### **CONVEYANCE LOAN SCHEME MODIFICATIONS IN THE SCHEME REVISION IN EXISTING LIMIT & EMI: NMI RATIO**

Revision in the loan limits in various categories of staff, modification of repayment period ratio, EMI/NMI ratio and extension of repayment to 70 years of age for pensioners.

**BANK'S MEDICAL REIMBURSEMENT SCHEME FOR AYURVEDIC TREATMENTS**

Competent Authority has approved the Bank's medical reimbursement scheme for Ayurvedic Treatments with improved benefits. By incorporating Ayurvedic treatment into medical reimbursement scheme, Bank aims to provide employees with a broader range of healthcare options, fostering a healthier and more productive workforce. Ayurvedic Doctors having BAMS or MD/MS Degree or Diploma in Ayurveda or Ph.D. in Ayurveda.

Older practitioners having qualifications like MFAM, DASF are also authorized to do Ayurvedic practice. There are Doctors designated as Acharya or Vaidya, but they have to be Registered Medical Practitioners to prescribe Ayurvedic treatments. Only medicines given in Ayurvedic treatises are reimbursable (Generic medicines) e.g. Ekal Dravya (single medication treatment), Kalpa (Tab, Syrup, Powders, Avaleha), etc. All 33 Pathology Investigations approved by the Bank as per Circular instructions, if prescribed by Ayurvedic Doctors, shall be reimbursed. Panchakarma Therapy is applicable to confirmed Officers only.

**WISDOM BYTES**

It is our constant endeavour at SBIOA (CC) to regularly update and guide our members regarding Banking knowledge and awareness. In this regard, we are introducing a new section from this edition of our SBIOA (CC) e-bulletin namely "Wisdom bytes" to constantly educate and update our members about the latest developments especially with regards to Disciplinary proceedings in the Bank, Business updates and the way banking ought to be conducted to safeguard ourselves and the interests of the Bank. Our members are requested to follow these guidelines meticulously, adhere to the systems and procedures without any deviation and spread the knowledge to all our colleagues.

**Attention: Processing officers at Branches, Credit Processing Centres, RBO's and AO's**

- **Due diligence: Know your customer (KYC)**
  - ◆ Exercise proper **due diligence while scrutinizing/ updating/recording KYC** of the applicants/ co-applicants/ guarantors. Please make it a point to interview the borrowers, gather as much information as possible and bring the necessary inputs into the proposal. PAN, Aadhar, Voter ID, RBI Defaulter / Wilful Defaulters List, ECGC Caution List, CIC Caution List, CIC Suit Filed List, SEBI Banned List of Promoters, CIBIL, Disqualified Directors List, UDIN, Udhayam certificate, GST returns, CGPAN, etc.

- Some of the lapses observed against our officers in recent times are as follows:
  - ◆ The official has not taken care to ensure the KYC norms while authorizing opening 250 SB accounts for the employees of M/s. xxx Pvt. Ltd. and thus, s/he failed to avert perpetration of fraud.
  - ◆ As a CSO/ RM (SME), have you carried out Due Diligence with regards to KYC as per Bank's SOP?
  - ◆ The borrower is having the following five accounts in ABC Branch with the same PAN id:
    - ❖ M/s. DEF Business Solutions
    - ❖ M/s. GHI Enterprises
    - ❖ M/s. JKL Cars
    - ❖ M/s. MNO Loan Bazaar
    - ❖ M/s. PQRS
    - ❖ These accounts were opened on 10th and 20th January 2017 and have become inoperative in 2018. Cheque dishonour charges debit observed in Wealth SBI A/c of the borrower and current A/c of M/s. JKL Cars. You have failed to scrutinize these accounts, while processing the proposal.
  - ◆ You had failed to carry out due diligence on the seller/builder credentials and thereby failed to comply with the instructions contained in Home Loan Master Circular prescribing additional due diligence on the seller/builder for home loans of Rs. 1 Cr. and above.
  - ◆ Due diligence on business of co-borrower/borrower Shri. TUV was not ensured properly by you. There was no GST registration for M/s TUV motors even though service income was more than Rs.50.00 lakh. Current account statement in the name of M/s TUV Motors was not on record. ITR verification was not done for all the financial years. There was no photo evidence for Pre sanction inspection. As per GST registered with his PAN, he is the Proprietor of M/s WXY Corp, which is engaged in construction activities.
